A RESOLUTION FIXING A TIME AND PLACE FOR PROVIDING FOR NOTICE OF A HEARING BEFORE THE GOVERNING BODY OF THE CITY OF BURLINGTON, KS.; AT WHICH TIME THE OWNERS, THEIR AGENTS, OR LIENHOLDERS OF RECORD OF THE PROPERTY HEREINAFTER DESCRIBED, OR ANY ADJOINING PROPERTY OWNERS CLAIMING AN INTEREST THEREIN, MAY APPEAR AND SHOW CAUSE WHY CERTAIN STRUCTURES SHOULD NOT BE CONDEMNED AND ORDERED REPAIRED OR DEMOLISHED AS DANGEROUS AND UNFIT STRUCTURES; PURSUANT TO AND UNDER THE AUTHORITY OF CHAPTER IV, ARTICLE 6 OF THE BURLINGTON CITY CODE AND K.S.A. 12-1750 ET SEQ, AS AMENDED.
