1	5-21-1969	Exempting the city from those parts of K.S.A. 12-110b which limit the annual tax levy for a firefighting equipment fund to a maximum of 0.50 mill and specify the types of obligations in which said fund may be invested, and providing substitute and additional provisions on the same subject.
2	7-21-1976	Exempting the city from the provisions of K.S.A. 14-103 and 14-201, relating to the election and appointment of city offices and providing substitute and additional provisions on the same subject.

2A	11-1-1978	Exempting the city from the provisions of K.S.A. 12-4112, and providing substitute and additional provisions on the same subject authorizing the assessment of court costs of cases heard in the Municipal Court of the city.
3	3-5-1980	Exempting the from K.S.A. 79-5011; providing substitute and additional provisions on the same subject; and authorizing the levying of taxes to create a special fund for the purpose of paying employee medical, health and hospitalization insurance and for the purpose of paying the entire cost of Social Security including both the employer=s contribution and the employee=s contribution and authorizing the levying of taxes to rate a special fund for the purpose of paying utility service costs.
4	9-29-1981	Relating to general improvements and land therefor; borrowing money and bond issues; when election required in the city, and exempting said city from provisions of K.S.A. 13-1024a, and providing substitute and additional provisions on the same subject.

This ordinance will amend Chapter VI, Elections and repeals Charter Ordinance 2 and Charter Ordinance 8.
795	2-16-2011	An ordinance to submit to the qualified electors of the city the proposition of approving Charter Ord. 8 and amending Chapter VI, Elections.

443	9-7-1988	Granting to the Coffey County Rural Electric Cooperative Association, Inc., a Kansas rural electric cooperative, its successors and assigns, an electric power franchise in certain portions of the city, prescribing the terms of the franchise and repealing all ordinances or parts of ordinances in conflict with the terms of this ordinance, approved September, 1995 for a period of 35 years.
585	9-20-1995	Granting to Kansas Gas and Electric Company, a Kansas corporation and wholly owned subsidiary of Western Resources, Inc., a Kansas corporation, its successors and assigns, the right to construct, operate lines over the streets, avenues and alleys of the city, for a period of 35 years.
596	4-3-1996	Granting United Telephone Company of Kansas a franchise to use the streets, avenues, boulevards, alleys and other public places in the city to continue to conduct the business of constructing, installing, maintaining, managing and operating a telephone system with all necessary poles, wires, cables, fixtures, conduit and apparatus.
689	9-19-2001	Granting to Mediacom Southeast LLC, the non-exclusive right to erect, maintain and operate in, under, over, along, across the streets, lanes, avenues, sidewalks, alleys, bridges, highways, easements dedicated for compatible uses and other public places in the city and the subsequent additions thereto, towers, cables and ancillary facilities for the purpose of constructing, operating, maintaining and repairing cable service for a period of ten years regulating the same and providing for compensation of the city.
